You are about to purchase a product that is not simple and may be difficult to understand

WHAT IS THIS PRODUCT?

Type

The product is in the form of a debt instrument, governed by English law.

Objectives

To receive a single payment on the Maturity Date or on any earlier Payment Date on which the product terminates in return for the risk of loss of capital. Amounts stated below are in respect of each Nominal Amount that you invest.

The amounts you will receive depend directly on the performance of the Underlying(s) and are determined by referencing the performance of Preference Shares which are directly linked to the Underlying(s). Therefore, for ease of explanation of the objectives of the product, the product is described in this document as being linked to the Underlying(s).

- Autocall Event: If the Worst Underlying Performance is greater than or equal to the relevant Autocall Barrier Level on any Autocall Valuation Date, the product will be redeemed early and you will receive, in addition to the Nominal Amount, an amount equal to the Bonus Amount corresponding to such Autocall Valuation Date on the immediately following Payment Date. No further payments will be made following such payment and early redemption.
- Redemption on the Maturity Date:
 - o Redemption Amount: If the product is not redeemed early, then you will receive one of the following:
 - If a Barrier Event has NOT occurred:
 - o If the Worst Final Underlying Performance is greater than or equal to the last Autocall Barrier Level, you will receive, in addition to the Nominal Amount, the Bonus Amount corresponding to the Final Valuation Date.
 - o If the Worst Final Underlying Performance is lower than the last Autocall Barrier Level, you will receive the Nominal Amount.
 - Otherwise, you will receive an amount equal to the Nominal Amount diminished by an amount equal to the Nominal Amount multiplied by the absolute value of the Worst Final Underlying Performance. The amount paid in such case will be less than the Nominal Amount and you may lose some or all of your capital.

All determinations and observations will be made by the Calculation Agent. All dates may be subject to adjustment for nonbusiness days and market disruption events.

- Underlying Performance: For an Underlying, (a) the Closing Value of such Underlying on any given date divided by its Initial Value, minus (b) 100%, expressed as a percentage
- Final Underlying Performance: For an Underlying, the Underlying Performance on the Final Valuation Date
- Worst Underlying Performance: The Underlying Performance of the Underlying having the lowest Underlying Performance
- Worst Final Underlying Performance: The Final Underlying Performance of the Underlying having the lowest Final Underlying Performance.
- Barrier Event: A Barrier Event shall be deemed to have occurred if the Closing Value of at least one Underlying is below 65% of its Initial Value on the Final Valuation Date
- Initial Value: The Closing Value of the Underlying on the Initial Valuation Date
- Closing Value: The value of the Underlying at the close of trading on a given trading day

- Bonus Amount: For each Autocall Valuation Date and the Final Valuation Date in chronological order: 10%, 15%, 20%, 25%, 30% or 35%, each multiplied by the Nominal Amount
- Autocall Barrier Levels: For each Autocall Valuation Date and the Final Valuation Date in chronological order: 0%; 0%; -5%; -15%; -25% and -35%

Early redemption and adjustments

The terms of the product provide that if certain defined events, in addition to those described above, occur (principally but not exclusively in relation to any Underlying, or the Manufacturer of the product (which may include the discontinuation of the Manufacturer's ability to carry out the necessary hedging transactions)), adjustments may be made to the terms of the product to account for the relevant event or the product may be early redeemed. The amount paid on any early redemption may be less than the amount originally invested.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Summary Risk Indicator



The risk indicator assumes you keep the product until 5 May 2028. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Crédit Agricole CIB Financial Solutions is not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a medium-high level; and 2) the credit risk which estimates that poor market conditions are very unlikely to impact the capacity of Crédit Agricole CIB Financial Solutions and the guarantor to pay you. If a PRIIP is denominated in a currency other than the official currency of the Member State where the PRIIP is being marketed, the return, when expressed in the official currency of the Member State where the PRIIP is being marketed, may change depending on currency fluctuations.
